

# Penal Code Section 597.1 – From Every Angle

## Instructor Biographies

### Chief Henry Brzezinski

Chief Henry Brzezinski has served as the Chief of El Dorado County Animal Services (Western Slope and South Lake Tahoe) for 11 years and the proud father of a new animal shelter. His passion for animal welfare has led to a 33-year career. He started his journey in South Carolina as a Humane Investigator after attending pharmacy school. During his time in the South as a lobbyist he drafted and attained passage of 22 state animal welfare laws. Chief Brzezinski was also a Field Investigator for the Humane Society of the United States, Mid-Atlantic Regional office. He has been recognized as an expert witness in several states. One of his many interests is researching and applying California animal laws.

### Mr. Harold Holmes

Harold Holmes is currently the Executive Assistant for the County of Los Angeles Department of Animal Care and Control. Most recently, he was a Deputy Director for the County of San Diego Department of Animal Services, retired as a Chief of Police in northern California and is a former U.S. Marine. He has experience drafting and shepherding legislation that became law at both the state and local level, including changes to PC 597.1. His assignment to run San Diego County's Dangerous Dog Task Force for three years inspired him to attend law school and was admitted to the Bar in June 2013. Mr. Holmes is also a hearing officer, a trained mediator and teaches a variety of legal and law-enforcement related topics.

### Captain Cindy Machado

Captain Cindy Machado is the Director of Animal Services for Marin Humane in Marin County, California. She began her career as an animal services officer with Marin Humane over 33 years ago. She is in charge of supervising the activities of the Animal Services division at Marin Humane as well as coordinating the Animal Law Enforcement Academies held there. Captain Machado's background and strong interests in various animal issues have resulted in hundreds of successful investigations and positive outcomes.

### Mr. Bruce Wagman

Bruce Wagman has dedicated his career to defending and improving animal lives. He is the only lawyer in a leading United States firm focusing solely on animal law. Mr. Wagman works at San Francisco's Schiff Hardin law firm with an almost exclusive focus on animal law matters, including litigation, legislative drafting and counseling. He also teaches animal law at three Bay Area law schools and has been involved in litigation and consultation with shelters, animal control officers, and county authorities on a wide variety of legal issues. Mr. Wagman is the coauthor of *Animal Law: Cases and Materials*, the main casebook for law school courses, and the lead author of *A Worldview of Animal Law*, the only global survey of animal law.
